Hans van den Broek was born in Paris (France) on December 11, 1936, is married and has 2 daughters.

He was Minister of Foreign Affairs of the Netherlands from 1982 to 1992 after having served as State Secretary for European Affairs from 1981 to 1982 and as member of the Dutch Parliament from 1976 to 1981.

From 1993 to 1999 Mr Van den Broek was Member of the Commission of the European Union with responsibilities for Enlargement and External Relations with Central and Eastern Europe, the Balkans, Turkey, Russia and the newly Independent States, Cyprus and Malta. As Commissioner he was also associated with EU's Common Foreign and Security Policy.
